**THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS,  
COLORADO**

**RESOLUTION SUBDIVIDING MULTIPLE PRECINCTS AS A RESULT OF  
INCREASED NUMBERS OF ACTIVE ELIGIBLE ELECTORS IN EXISTING  
PRECINCTS, IN ACCORDANCE WITH SECTION 1-5-101(3), C.R.S. AND  
RESOLUTION R-022-005 AND MODIFYING EXISTING PRECINCT BOUNDARIES  
AND ESTABLISHING SIX NEW ELECTION PRECINCTS IN ACCORDANCE WITH  
SECTION 1-5-104(1), C.R.S.**

*WHEREAS*, Douglas County has continued to experience significant growth since the current precinct boundaries were created pursuant to R-022-005, and several precincts have more than twice as many active eligible electors as they did at the time they were established; and

*WHEREAS*, Resolution R-006-034 authorizes the County Clerk and Recorder to establish at least one precinct for every two thousand eligible electors; and


*WHEREAS*, Section 1-5-104, C.R.S. permits change in the boundaries of election precincts as well as the creation of new precincts such as those proposed herein;


**NOW THEREFORE BE IT RESOLVED, BY THE BOARD OF COUNTY  
COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, that multiple precincts be subdivided to create an additional six precincts as depicted on election precinct map attached hereto, is hereby approved, and said election precinct map shall be filed with the office of the Clerk and Recorder of Douglas County; and

**BE IT FURTHER RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
THE COUNTY OF DOUGLAS, STATE OF COLORADO** that the modified precinct boundary descriptions and the creation of six new precincts as depicted on the precinct map attached hereto, are hereby adopted and approved, resulting in a new total of two-hundred and sixteen (216) precincts.

**BE IT FURTHER RESOLVED** that this change shall be effective as of 07-11-2025. **PASSED  
AND ADOPTED**, this 27<sup>th</sup> day of May 2025 in Castle Rock, Douglas County, Colorado.
